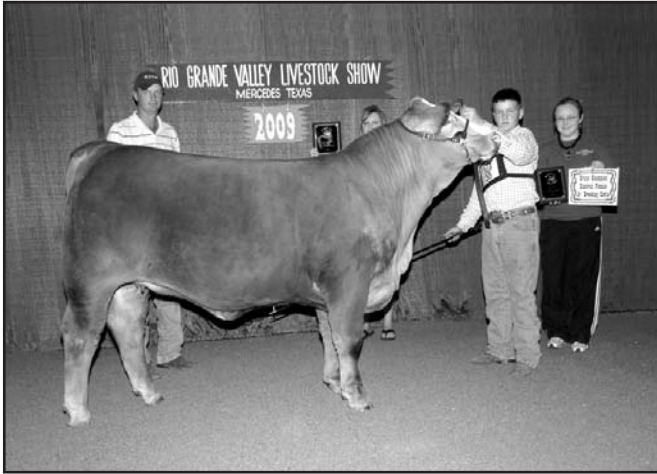




JR. SIMBRAH DIVISION
